Note: The Rifle Range is considered closed to all Members during hours that the Club is under a rental to another party or being used for instructional purposes such as Hunter Education or Law Enforcement qualification. It is also closed when clay target shooting of any type is in process, unless permission is received from the individual in charge of the clay target shoot. Please check the schedule of events posted on the Club website www.kalbfus.com or in the display case located by the clubhouse door.
